We only collect information necessary for secure registration and site usage, and to make it possible for us to send you informational updates about Executive Education.

The statements below outline our privacy policy and the reasons behind the information that may be requested.

- You do not have to give personal information except what is required for us to process your registration. These fields are required during the online registration process.
- We will not share your personal information with outside agencies, except as required by a law enforcement agency.



- Personally identifying information you provide, such a last four digits of Social Security numbers or employment history, will be used only in connection with Executive Education registration and services.
- Other contact information is only used internally by CWRU, and does not contain personal identifiers that would be subject to privacy concerns.
